



Chamber Articles and Bylaws Vote:

In April Chamber members participated in our first electronic ballot. The ballot was for the approval of revisions to the chamber's Articles and Bylaws. Ballots were emailed to members who have provided email addresses and were mailed to those who did not have an email address on file. A total of 37 completed ballots were returned. 100% of returned ballots were marked yes to both questions. With 67% of eligible chamber members voting, both questions passed.
